

- Putting in a pier? **Make sure you know the rules for piers.** Check this out at the Indiana DNR website, [in.gov/dnr/water](http://in.gov/dnr/water)
- **Don't feed the geese or ducks.** When ducks and geese get food from us, additional waterfowl who visit our lake will stay because it appears that there is plenty of food.
- **Let us know you've moved in.** We'll send you a New Neighbor Gift Bag.



# SUPREME COURT WETLANDS RULING

Thanks to Bev Weimeri, lake resident, for forwarding this information from Indira Frank, of the Hoosier Environmental Council which we have included in this article.

“On May 25 the Supreme Court issued an opinion in the case of Sackett v. EPA which will substantially reduce protection for wetlands across the U.S. and in Indiana. Prior to this opinion, the majority of Indiana’s remaining wetlands were under protection of the federal Clean Water Act, but the court’s statement means the majority of wetlands will no longer qualify.”

## WHO BROUGHT THIS CASE TO THE SUPREME COURT?

“Michael and Chantell Sackett have been battling with the federal government for over 15 years in their efforts to build a house on an empty lot near Priest Lake in Idaho. The Sacketts’ legal battle began shortly after they began backfilling their property to prepare the lot for construction, which is about 300 feet from Priest Lake, back in 2007. The Sacketts received a notice from the EPA to stop work because their lot contains wetlands protected by the CWA, which bars the discharge of pollutants, including rocks and sand, into “navigable waters.” The Clean Water Act defines navigable waters as “waters of the United States.” The EPA reasoned that the wetlands on the Sacketts’

lot fed into a non-navigable creek that then led to Priest Lake.”

“The Supreme Court reversed the lower court’s decision and said that “we hold that the Clean Water Act extends to only those “wetlands with a continuous surface connection to bodies that are ‘waters of the United States’ in their own right,” so that they are “indistinguishable” from those waters.” The wetlands at the southeast corner of Little Simonton run right up to the shoreline. This seems like it would make it a “continuous surface” making the wetlands protected. But, we need to keep watch on this.

While environmentalists are extremely worried about lowered protection for wetlands, builders and farmers often find that the wetlands laws are too stringent.

## WHY ARE WETLANDS IMPORTANT?

They “catch and hold excess stormwater, like giant sponges on the landscape, helping to reduce flooding. While the water is held in wetlands, it is filtered, purified, and allowed to soak in and replenish groundwater for our wells to tap. Wetlands are also among the most biologically productive ecosystems. According to the Indiana Department of Natural Resources, wetlands provide habitat for 50% of Indiana’s species with small or declining populations.”

# ANNUAL MEETING OF THE SIMONTON LAKE AREA HOMEOWNERS' ASSOCIATION

On May 17 the Simonton Lake Area Homeowners' Association held their annual meeting at the Sportsmen's Club. About 70 people came for the dinner and more arrived for the meeting which immediately followed.

We currently have 258 members. Our membership campaign 2024 will begin in January. A treasurer's report was given as well as reports by each of our committees: Environment, Safety, Communication and Membership/Outreach.

**SWAN REMEDIATION** A presentation was given by Carl Vogleweden who explained how the swans will be removed from the lake.

**GEESE** We have raised most of the funds to start the relocation of the geese. This will take place in late summer or early fall. In the meantime, some lake residents are having good luck in using green laser pointers. Residents are reminded not to feed the geese.

## CONSERVANCY REPORT

- Spraying for invasive weeds will be done in June and in August. A postcard will be sent to you if you are not to use your sprinkler system.
- The Board is looking into placing Dry Hydrants on the lake for use by the fire department.
- Solar-powered lights will be placed on the top of each buoy by volunteers before Memorial Day.

## INDIANA LAKES MANAGEMENT SOCIETY

Simonton Lake is now a member of this state-wide group which educates lake residents, provides resources and lobbies at the General Assembly.

**FISH KILL-A IDNR** official visited Simonton Lake to investigate the higher than usual number of dead fish. Other lakes are seeing the same thing. The finding is that the great fluctuation in water temperature in the spring led to the demise of the fish.

**ISSUES AT THE PUBLIC LANDING** We continue to monitor parking in no parking areas, blocking the boat ramp, vandalism, and suspicious activity. For issues dealing with a DNR rule like blocking the landing or parking in a no parking area in the parking area, call the DNR Central Dispatch at 812-837-9536. For suspicious or dangerous activity or parking along C.R. 109 call the Elkhart County Sheriff's Office.

**FUTURE GOALS** There are four organizations at Simonton Lake: the HOA, the Sportsmen's Club, the Conservancy, and the Trust. It is the goal of the HOA that all these groups work together for the common



good. We also hope to work with the county to keep Lily Creek clear of vegetation. We are looking at some nice Welcome signs to place along the main roads. Finally, we are looking into getting stop signs on C.R. 11 and Aqua as well as C.R. 11 and North Shore Drive.

Finally, Doug Reese announced a Simonton Lake promo from Bordon Waste Away.

## WHAT NOT TO PUT INTO THE SEWER

There are some things you can do to make your grinder pump continue to work.

**Remember these letters: F.O.G.S.**

**F stands for Fats**

**O stands for Oils**

**G stands for Grease**

**S stands for Sanitary "disposable" wipes**

Grease and fats clog up pipes which eventually need to be cleaned out. And, those disposable sanitary wipes, well, for our system, they are NOT disposable.

**BOTTOM LINE: DO NOT PUT F.O.G.S INTO THE SYSTEM!**

The DNR has installed the ADA compliant pier and will remove it in the fall. This ensures that those with disabilities are not excluded from enjoying the lake



## BE CAREFUL WHERE YOU DIG!

The sewer system is pressurized. If you puncture the line, you will have a fountain of sewage. Call 811 before you dig!

## SUMMER WEED SPRAYING

Check the SLSC website for dates of summer weed spraying.

If you get a card from Aquatic Weed Control, then the chemicals they are using are harmful to your lawn. The card says not to use your sprinkler system.

If you see Aquatic Weed Control spraying but you have not received a card, DON'T PANIC! The chemicals they are using are not harmful to your lawn.

After every spraying near your property a yellow flag will be placed on your lawn.

### PLEASE NOTE:


Aquatic Weed Control will treat the channels the WEEK of June 13<sup>th</sup>.

After our application, yellow flags will be posted in the yard listing the water use restrictions of three (3) days using water out of the channel to water yards and ornamental plants.




## GRADUATION

# HEY, WHERE'S THE LAKE?

INFORMATION ON FENCES BY BOB MYERS

It certainly can be frustrating to have a picturesque view of Simonton Lake blocked by a fence, a boat house or shed. Can you imagine greeting guests who walk to the lakeside of your property and say, "I thought you lived on a lake." And your response is, "I do. The lake is on the other side of that fence and behind those boat houses." People purchase homes on a lake partially because of the view of the surrounding landscape. Also, the value of a particular home may depend to a great degree on the view.

People build fences on lake property to keep pets or children in, keep neighbors, other people's children, or other people's pets out or provide privacy. All are valid reasons. How you construct that fence and where, and the view you may be denying your neighbor are of concern.

**INDIANA CODES ON FENCES**-Elkhart County has no specific regulations regarding fences. They defer to the laws set up by the State of Indiana. SEE INDIANA CODE 32-26-9-1, 32-26-10-1, 32-26-5-1

- In Indiana, a fence cannot be taller than six feet and cannot be built or maintained in a way that purposefully annoys adjoining landowners.
- If a fence is constructed or maintained to purposefully annoy adjoining landowners, it can be considered a nuisance. In the State of Indiana there is a "Spite Fence Law." This statute evaluates whether a structure is to be deemed a private nuisance and should be removed. Even if the fence is built to State standards it can still be found in violation of the state "Spite Fence" law. An example of a previous case is one where a resident of Indiana built an 8-foot fence with barbed wire on the top in a residential neighborhood. This was deemed to be a "spite fence" and was ordered removed.
- All fences "shall be erected with the finished side facing toward the property line."
- Do I need a permit? If your fence is 6 ft tall or under, you will not need a permit.
- Can you build your fence on your lot line? Yes, but make sure to determine where the lot line is and not just where you think it is. Officials recommend a stake survey to determine that lot line.
- Can I build a fence down to the seawall? **There are no state or county laws that prohibit this.**

If you previously had an unobstructed view, and now your neighbor has built a structure blocking it, and you are unable to work out a solution with your neighbor, you may want to explore your options with an attorney.

If a fence is "unsightly and needs repair" you may use a "fence viewer." Indiana law provides for fence viewers to serve as an out-of-court dispute resolution function. These viewers are usually ordinary citizens appointed by a local official. Upon request, the fence viewer inspects a property, considers whether the fence needs repair. The decision of the fence viewer is binding on the neighbors, although it can be appealed in court.

*Question: If I build a fence that obstructs my neighbor's view, won't it obstruct my view as well?*

# THE OSOLO TOWNSHIP VOLUNTEER FIRE DEPT

Upon learning that Simonton Lake had a quarterly magazine, Chief Smith asked if he might write an article for each issue. We were happy to say yes. For his first article we asked Chief Smith to compose an overview of the firehouse, the firefighters, and the fire station and give us a little history as well. The Osolo Township Volunteer Fire Department was founded by local business owners, school bus drivers, and residents in Osolo Township back in late 1950's. Back then the township contracted with Elkhart City for fire protection. When a home or business caught fire, Elkhart City sent 1 truck with 3 firefighters and when they ran out of water they returned to the city and the building was left to burn.

So, Osolo Fire Department was created for the protection of the residents and businesses. We are located at 24936 Buddy Street which is south of C.R. 6 and on the east side of C.R. 11. We have been on the same ground since the laying of the first cement block back in 1957. The station opened for service in 1958.

Although Osolo Fire started as a volunteer department, today it has grown into a combination department with 15 full-time career firefighters, three part time firefighters, and six volunteer firefighters serving the township. Our current fleet consists of a 100 ft. ladder platform truck, one main line engine and one reserve engine, two tankers, a brush truck, a rescue truck, a command vehicle and one fire boat. The Osolo Fire Department runs an average of 1500 calls a year between fire, EMS, and mutual aid to neighboring fire departments. The department covers approximately 25 square miles including Simonton Lake and six miles of the Indiana Toll Road.

## CALL ELKHART COUNTY CODE ENFORCEMENT

Simonton Lake is part of Elkhart County. When you need the police, you call the County Sheriff's Office. When your neighbor doesn't mow or has several junk cars in their lawn you call Elkhart County Code Enforcement which is part of the Planning and Development Department.

Elkhart County does have laws regulating homes in our neighborhoods including:

- weeds and rank vegetation,
- lawns over 8 inches tall,
- junk cars in lawns, debris in yards,
- structural issues regarding homes,
- sheds or other structures,
- trash and outside storage,
- people living in tents,
- unattended trash or leaf fires or
- RVs parked in a neighborhood.

The Elkhart County Planning and Development Director is now Mae Kratzer. She is a former resident of Cottage Avenue and familiar with Simonton Lake.

The job of enforcing the county codes is driven by complaints, usually from neighbors who believe someone may have violated an ordinance. County

Enforcement Officers have as many as 30 investigations each day. The bottom line is: If you do not call in a violation, the county does not know there is a problem.


### TO SUBMIT A COMPLAINT

- Document your concerns with pictures. Document dates and times of incidents (smelly, standing water in the yard, dates of when the yard was last raked or mowed, etc.)
- Then call the Elkhart County Planning and Development Office with the address of the property in hand. Your call is confidential.
- Elkhart County Planning and Development Phone: 574- 971-4678
- Ask for Code Enforcement. Depending on the type of complaint you may be sent to Nuisance Enforcement or Zoning Enforcement.


# FIBER INTERNET? IT'S COMING TO SIMONTON LAKE

At the beginning of 2023 Elkhart County partnered with internet provider ChoiceLight. Under it, the county retains ownership of the existing underground cables and the regional not-for-profit manages all the operations. ChoiceLight is no stranger to Michiana. In the last 20 years, they have brought telecommunication infrastructure across 300 miles of cables to St. Joseph and Marshall Counties. This partnership with Elkhart County creates one regional network of nearly 500 miles of cable.

The cables currently in the ground are what is known as dark fiber. That means they are not yet "lit" or being used by a service provider. These will be open access, which will allow multiple different service providers to bring internet access to customers.



One of the providers at Simonton Lake is Surf Internet. We asked their representative, Scott Franko for some information on this new type of service.

"Fiber-optic internet uses light signals to connect you to the Internet. Unlike cable, where entire areas of town share the same cable, every customer gets their own fiber optic strand so there's no sharing with all your neighbors. That means a more consistent and reliable Internet experience. Fiber internet offers the speed and stable connection you need to stream all your favorite movies, shows, news and sports from whichever streaming service you choose.

Fiber-optic internet service is future proof. There is no practical limit to the amount of capacity or speed fiber can provide. And, since the fiber wire is buried underground, it is immune to lightning and thunderstorms.

### FIBER OPTIC CABLE FACTS

*A fiber optic cable is a network cable that contains strands of glass fibers inside an insulated casing.*

*Fiber optic cables provide higher bandwidth and transmit data over longer distances than wired cables.*

*Fiber optic cables do not overheat and are not affected by weather factors, making them more invincible than copper.*

## OTHER ALTERNATIVES:

- Leaves can be dropped off at the Elkhart County Landfill for no cost. The landfill is at 59530 County Road 7 South of Elkhart.
- If you have a compost pile or bin, leaves can be added.
- Placing leaves in your garden in the fall will bring you enriched garden soil come spring.

## IF YOU ARE SUFFERING FROM A NEIGHBOR'S FIRE:

- Talk to your neighbor.
- If necessary, call the Elkhart County Police and let them know you are having trouble breathing because of a fire in the neighborhood.

**If you must burn, be sure to follow the Elkhart Count burning ordinance:** Fires must be attended during burning until completely extinguished.

- A fire must be extinguished at any time if it creates a:
  - Pollution problem
  - Threat to public health
  - Nuisance
  - Fire hazard
- Burning may not be conducted during high winds, temperature inversions, air stagnation, or when a pollution alert or air quality action day has been declared.
- Private residential open burning must be during daylight hours. All fires must be extinguished before sunset. (Recreational or ceremonial fires are allowed after sunset but cannot be used for disposal purposes.)
