BOATERS CAUSE HAVOC WITH FIREWORKS

Simonton Lake Conservancy Takes Over Drainage, Erosion and Weed Control

The following letter was sent from the Conservancy Board to the SLAHA Board of Directors.

May 21, 2018

To: The Simonton Lake Home Owners Association

The Simonton Lake Conservancy District with its newly adopted Purposes, will now be assuming all responsibilities and implementation for the additional Purposes which would include future dredging, drainage and watershed projects. We will also continue with weed control in all channels and specific lake areas as needed.

All homeowners are welcome to attend the Conservancy meetings at any time to voice input on needs for the lake area and discuss current and future projects related to the Conservancy District. Please call our of-fice at 574-206-8485 for meeting dates and times.

We also plan to post our budget and all future projects on the SLHOA website as we progress.

Regards, The Simonton Lake Conservancy District Board of Directors

After a two-year legal process the Simonton Lake Conservancy District has been given additional authority to:

- 1. Improve Drainage
- 2. Develop Forests, Wildlife Areas, Parks and Recreational Facilities
- 3. Prevent Erosion
- 4.Operation, maintenance and improvement of any work of improvements for water-based recreational purposes (Dredging, Water Quality, Weed Control)

The original purpose given to the Conservancy when they were established in 1999 was collection and disposal of sewage. This purpose will continue.

This is a big undertaking for the governmental body. The circuit court also approved a "District Plan" which lays out how the Conservancy is to accomplish their new legal commitments. "The District Plan" is available on the Lake Association Webpage.

WHAT THIS CHANGE-OVER MEANS TO YOU

For the last several years the Lake Association has led projects such as dredging, weed control, and maintenance. Volunteers have written grants, sought out and gotten county funding, worked with contractors, attended countless meetings, written detailed proposals, and spend hours working on behalf of the community. It has been overwhelming for a group of volunteers continually trying to obtain grants and governmental funding.

The Lake Association will continue to do things which build community like our New Neighbor program, Garage Sale, Lake Alert System, Website, Calendar, Safety issues and Newsletter.

And, now that the burden for some projects has been shifted to the Conservancy, the Lake Association can enhance other current projects and programs and can look for other ways to serve our community.

What About the Current Dredging Project?

The Lake Association Environmental Committee will complete the current dredging project with a planned finish date of December 2018. No funding for this project came from the Conservancy funds.

What About Weed Treatment this Summer?

The Conservancy will organize and pay for this project.

What About Current Drainage and Erosion Issues?

Drainage and erosion issues should be taken to the Conservancy.

Bob Paul retires, Randy Hoff Steps Up New Chairman of Environment Committee

For three years Bob Paul has been the Chairman of the Environment Committee. Bob came on board as we began our dredging project. The position was one which we thought no one in their right mind would take. The project required lots of hours, state and federal permits and requirements, engineering studies, meetings with county officials, dredgers, state officials, and so on.

We at the lake were very lucky because Bob Paul stepped forward. Bob has spent countless hours working on dredging. He has worked on weed control, erosion and drainage issues. His expertise and willingness to give his time and energy was invaluable. When you see Bob (and his wife Kathy) say Thank you.

With the dredging project near completion, Bob announced his retirement. It was announced at our Annual Meeting in May that one of our leading lake citizens has stepped up. Randy Hoff, longtime lake resident, will take the reins of the committee. Bob Paul will continue any work needed on the dredging project and Randy will work alongside him. Randy is appreciative of Bob's work and has some great ideas for the committee in the future.

Randy and his wife Gina have lived on the Forest Road channel - for many years.

SAFETY COMMITTEE MEMBERS RESIGN

Paul Wilson, chairperson of the Safety Committee and Bob Kelsey committee member have resigned. Bob was also a member of the Association Board. He has resigned this position as well.

Both men are members of the Simonton Lake Conservancy Board. The Conservancy Board is now responsible for drainage, erosion and maintenance such as weed control in addition to the sewer system. So, they'll be very busy.

CRIME REPORT

May 2018 a construction trailer was stolen on Lake Drive.

Early on Monday morning June 25th, a burglar was chased from a home on Maplewood. The homeowner who chased the burglar had the presence of mind to have his cell phone in hand and got a picture of the burglar's license plate. He was later apprehended by the police and was arrested. Also, around that time another resident of Maplewood heard what she thought might be gun fire. It was not. But, someone had thrown something through a large window of a home that is currently not occupied. It was not clear whether the same suspect was responsible for this incident.

Tuesday, **June 26**, the same person arrested the day before and now out on bail, was back in the same neighborhood of Maplewood. Police were called. A warrant is out for his arrest.

Sunday, **July 8**, between the hours of 5 and 8 p.m. a white Ford F150 was stolen out of the driveway at 25290 N. Shore Drive. This truck was pulled into a driveway way off of the street. The home is not visible from the road. Someone had to be looking hard for something to take. By 6 pm the truck had been recovered from Beverly Shores, Michigan City. After a short high-speed chase, police arrested the driver. Inside the truck were items from Elkhart and Edwardsburg homes. This same driver may have been seen by a resident the previous week on Vernon Crossing leaving a different stolen car.

Sunday, **July 8.** The security system at Wakeside Marina captured photos of suspected burglars outside of their fenced-in property attempting to break in. The Elkhart County Sheriff's Department was on the scene within minutes. Unfortunately, no arrests were made. Thankfully their security system was working and no damage was done. A security camera detected persons at a barn and car port area of a home in the 25000 block of North Shore Drive (Little Simonton) on Monday morning **July 9** about 5:30 a.m. The building is clearly marked as having an alarm system.

On Tuesday, **July 10** a person came to the same residence. Home owners believed him to be the same person detected by the cameras the night before. The resident described him as early 20's, blondish-red hair, skinny. When the door was answered the man claimed to want directions to Cassopolis Michigan. The police were called. At that time the man was driving a dark color car with gold tone wheels and a handicap tag in the window. The license number is Indiana 121 KAW

July 12. The Porter County Crime Times, an online reporting site, reports that Jeffrey Clinch, 35, Elkhart, was arrested in Michigan City in the Ford F150 that he stole on July 8. He was charged with auto theft, theft and driving while suspended. Elkhart County Police confirm that Jeffrey Clinch is linked to the incidents on Maplewood and North Shore Drive.

Saturday, **July 14**. A car window was smashed in the driveway in the 25000 block of North Shore Drive. The police were called.



When an incident occurs in your neighborhood, first call the police, then let us know so that a LAKE ALERT can be sent out. We currently have 250 persons on the list.

PUBLIC AREA DREDGING

Preparations are underway for completion of the Dredging Project by the end of this year. This phase of the dredging work is fully funded through grants from the Indiana Department of Natural Resources and the Elkhart County Stormwater and Drainage Board MS4 Fund.

Our dredger (Superior Seawall & Docks) will soon be on site to modify the Sediment Basin located just south of Vernon Crossing. The Basin has been redesigned by Cardno Environmental Services in accordance with the revised Storm Water Pollution Prevention Plan approved by the Elkhart County Stormwater and Drainage Board. This basin work should be completed by mid-August.

The Hydraulic Dredging operations are scheduled to begin immediately following the Labor Day holiday and are expected to be completed shortly after Thanksgiving (weather permitting).

AREAS TO BE DREDGED ARE

- 1. From the mouth of Forrest Channel north along the western shoreline of the East Basin to the Narrows;
- On the northern shore of the Narrows along Ola Crain's property to the mouth of the Watershed Drainage Channel, then east along the northern shoreline of the East Basin until it intersects the east end of the Narrows Channel which was dredged two years ago;
- 3. Along the curve of Wogoman's Cove at the northwest corner of the West Basin; and the Channels.

The hydraulic piping associated with the pumping method will be located so as to minimize interference with boating activities, but boaters are asked to be alert and take care to avoid the floating pipe. Trying to cross over a pipe could cause damage to boats and motors. All areas of dredging will be staked in late August and boaters are asked to respect the markers. Your cooperation is requested as we undertake this important effort in improving the lake we all love.



SLAHA ANNUAL MEETING AND DINNER

At 7:00 our meeting was called to order. The first report was made by Susie Broderick, treasurer. She reported that the Board had decided early in the year that our dues will run by calendar year which will be easier to manage. The balance is \$262,116.41 and we have 246 Association members. Much of this money will be spent on the upcoming sediment removal project. A \$5,000 check was presented to the Sportsmen's Club for the fireworks.

Paul Wilson of the Safety Committee reported that all buoys are in the water. A change has been made to protect them from theft. More buoys have been added around the Ecozone. Safety issues should continue to be reported to Chris Toles.

Gina Hoff of the Membership Committee explained that they head up and assist with the membership drive, organize the neighborhood garage sale, distributes "New Neighbor Bags" and help with the annual meetings and other social activities.

Amy Matherly chair of the Newsletter Committee explained the people responsible for the communication within our SLAHA Community. We are on Facebook, Erin Lucas is chair of our website, www.simontonlake. org. Our graphic designer is Angela Black. Steve Wogoman handles the newsletter distribution. Lake Alerts are sent out via email about safety concerns around the lake.

Bob Paul, outgoing chair of the Environment Committee made a report. He reported that the county has been out and involved in helping to assist in the area drainage and flooding problems. Weed treatments are being done by the Conservancy. Residents can treat weeds up to 600 ft. from your seawall and use Hydrafoil/91 with no permit needed. A general explanation of the fall dredging was made. Randy Hoff will be replacing Bob as chair.

A short explanation of the Watershed Management Plan was made by John Richardson from Cardno. The county requested the Lake Association have this study conducted for future possible solutions for our erosion and drainage issues. The cost of this study is \$45,000.



County Code Enforcement Helps with Neighborhood Issues

NOTE: The Lake Association receives many calls and e-mails about neighbors who don't mow, have debris in their yards or are violating zoning laws like running a construction business in their yard, running a business from their home with lots of traffic or having permanent lawn sales.

The question is: Who do I call? Well, here is the answer. Read on.

Officials say Elkhart County is moving forward with a plan to give officers the authority to write tickets when they see code violations. A measure sponsored by state Rep. Doug Miller allows counties to partner with municipalities so a local ordinance violations bureau or town court can deal with low-level violations without the need for extensive processing or potential legal battles.



Elkhart County planning and development director Chris Godlewski said the **job of code enforcement is driven by complaints**, usually from neighbors who believe someone may have violated an ordinance. County Enforcement Officers have as many as 30 investigations each day.

Officers can send mowing contractors out to the properties of violators and bill the owners for work done. Any unpaid bills must go to the county auditor, who can place a tax lien on the property. Inoperable vehicles that must be towed are handled by the sheriff's department. The new ticketing program was expected to start sometime this summer.

TO SUBMIT A COMPLAINT

Document your concerns with pictures. Document dates and times of incidents (smelly, standing water in the yard, dates of when the yard was last raked or mowed, etc.)

COMMON COMPLAINTS ARE

- Weeds and rank vegetation, over 8 inches tall,
- Junk cars
- Tall grass
- Debris in yards
- Structural issues
- Trash and outside storage
- People living in tents, sheds or RV's in a neighborhood

Call the Elkhart Planning and Development Office with the address of the property in hand. **Phone: 971-4678**. Ask for Code Enforcement. They may send you to Nuisance Enforcement or Zoning Enforcement.

Weed Control

NOTE: A few years ago the Environment Committee of the Lake Association created a Weed Control Committee. At that time the Lake Association was the only organization working on this problem. While the Lake Association will continue to monitor invasive weeds, the responsibility for treating the weeds and paying for the weed treatments will now go to the Simonton Lake Conservancy.

All channels were sprayed on June 29. All residents of the channels received a post card in the mail telling the date they would be treated and flags were

left in the yards. No report on when Stary Stonewart will be treated. As you remember from previous articles, Stary Stonewart is a very invasive weed and is already present in Simonton Lake.

Residents of the channels reported weeds so bad this year that motors struggled to get through. We must remember to put no-phosphorus lawn fertilizer on our lawns. The run-off of fertilizers with phosphorus feeds the weeds.

FEEDING THE DUCKS IS FOR THE BIRDS

Tossing a few pieces of stale bread crumbs to the lake's duck and swan population is fun, right? Hearing a child squeal in delight as the fowl flock within arm's length makes for fond summertime lake memories. But what if this harmless, memory-making pastime was not so harmless?

You always see signs touting, "Don't Feed the Ducks". As I have watched various neighbors relishing in attracting waterfowl to their piers with a plastic bread bag in hand, I wondered how safe it is to feed these wild animals human food. If some humans cannot digest gluten-laden foods, can ducks, swans and geese? So, I did some research.

> Feeding the Birds increases their susceptibility to disease and causes them to concentrate on handouts.

According to the Indiana Fish & Wildlife website, feeding the local waterfowl is not only harmful to the animals, it can cause overcrowding populations in the lake and delay the natural migration patterns of the birds. Here's why.

"Many environments can provide sufficient space and food for small populations of water-



fowl. However, as thousands of waterfowl concentrate in areas because handouts are easily attainable, the once wild birds can soon become tame, lose their fear of people and pick up habits that conflict with the human population and the birds' natural patterns of migration", states the free

pamphlet published by the U.S. Fish and Wildlife Service. As waterfowl become more and more accustomed to free handouts, they limit their search for lake vegetation and concentrate on the easier pickings from human feedings. This attracts more ducks, geese


and swans to the lake, increasing the competition for food. The waterfowl stay on the lake longer than they normally would, adjusting their migration pattern, sometimes stranding the fowl in the harsh, freezing winter weather.


In addition, the stress of a less nutritious diet of human food, "Increases their susceptibility to life threatening diseases like avian cholera, duck plague and avian botulism. These diseases have the potential to kill off large numbers of waterfowl," according to the same publication. The result is the spreading of these diseases within the waterfowl population similarly to spreading the common cold in the human world. We have all seen the damage that too many Canadian Geese can cause to yards and docks. The Indiana Department of Resources (DNR) states that the single most effective technique home owner associations should employ to control the geese population is to adopt a no-feeding policy.



An evening pontoon ride on Simonton Lake wouldn't be complete without spotting a flock of ducks paddling in the big lake or a pair of white swans swimming with their brood of newly hatched cygnets in the main channel. It's part of what we love about our lake. But if you truly care about the waterfowl and preserving their natural habitat here on the lake, please stop feeding them.



I am new to the lake but I understand that a weir was built across the creek which empties out our lake to keep our lake from getting too low in the summer when we go without rain. Is the Weir keeping too much water back and causing the flooding this winter and spring?

Answer: Bob Paul, Environment Committee Chair

After decades of work by lake residents the Weir was installed in 2016. The Weir is set at the legal lake limit. Water above that level flows over the top with no restriction. Prior to 2016 when there was no weir we have had flooded streets and wet basements. This year was particularly bad but the Weir is not part of the problem.

RE: Fireworks

My wife and I are trying to get our one-year-old to sleep and our neighbors are still shooting off fireworks. What can I do? Is there a law on this?

Answer: From the Elkhart County Police

The use of fireworks in the unincorporated areas of Elkhart County is still prohibited with the exception of the following days and times:

- Between the hours of 5:00 p.m. and two (2) hours after sunset* on the following dates:
- June 29, June 30, July 1, July 2, July 3, July 5, July 6, July 7, July 8, and July 9
- Between the hours of 10:00 a.m. and 12:00 midnight on July 4

(and between the hours of 10:00 a.m. on December 31 and 1:00 a.m. on January 1)

*Sunset is approximately 9:20pm on these dates, making approximately 11:20pm the latest time to set off fireworks.

Violation of this ordinance may result in fines totaling up to \$500, in addition to court fees. Call the Elkhart County Police.

Answer from Steve Wogoman: These anchors can be made with PVC pipe. There are plans on the internet. However, there are also pre-made ones that can be bought from suppliers. Google it.

"SWIMMER'S ITCH"

Earlier in the summer several people around the lake experienced what is commonly known as "Swimmer's Itch."

WHAT IS IT?

According to the Mayo Clinic, "Swimmer's Itch" is an itchy rash that looks like reddish pimples or blisters and can occur after you go swimming or wading outdoors. Also known as cercarial dermatitis, "Swimmer's Itch" is most common in freshwater lakes and ponds, but it occasionally occurs in salt water. The rash usually affects only exposed skin, not skin covered by swimsuits or waders.

HOW DO YOU GET IT? Swimmer's itch is caused by an allergic reaction to parasites that

burrow into your skin while you're swimming or wading in warm water. The parasites that cause swimmer's itch normally live in waterfowl and some animals such as geese, ducks, gulls, beavers, swans and muskrats. The parasite's eggs enter the water via their hosts' feces. Before infecting birds, animals or people, the hatched parasites must live for a time within a type of snail. These snails live near the shoreline, which explains why infections occur most often in shallow water.


HOW LONG DOES IT LAST?

Humans aren't suitable hosts, so the parasites soon die while still in your skin. "Swimmer's Itch" is uncomfortable, but it usually clears up on its own in a few days. In the meantime, you can control itching with over-the-counter or prescription medications. It is not contagious. Talk to your doctor if you have a rash after swimming that lasts more than three days.

HOW CAN I PROTECT MY FAMILY?

If swimmers near your beach have gotten Swimmer's Itch rinsing exposed skin with clean water immediately after leaving the water and then vigorously dry your skin with a towel is recommended. Also, launder your swimsuits often.

WAYS YOU CAN MAKE A CLEAN, CLEAR LAKE

One way we sustain our water quality is to NOT stir up the bottom. Stirring up sediment clouds the water and releases phosphorus from the lake bed. Our goal is to leave that sediment alone as much as possible.

What can You do? _____

PHOSPHORUS

- 1. Don't use it!
- 2. Seaweed uses phosphorus to grow.
- 3. Tell your lawn care provider that you only want zero phosphorus fertilizer
- 4. Once phosphorus is released into our lake it STAYS in the sediment

PRESERVE OUR LAKE BOTTOM

- 1. Stirring the lake bottom suspends the phosphorus
- 2. Accelerating in shallow water creates sediment plumes.
- 3. Wakeboard and surf in deeper water.
- 4. Whenever possible begin pulling skiers and tubers in deep water.

DIMINISH WAVE ACTION

 If you have a metal or wood seawall consider glacial rock in front of that seawall. That will diminish the slapping of the waves and the disturbing of the lake bottom



SIMONTON LAKE SAFETY TIPS

Many thanks to **Gianina Chard** for sharing this information with Simonton Says readers.

With the recent burglaries and attempted burglaries around the lake, we are grateful to our County Police Officer, Joe Milovich, who wrote this article. Of particular interest is the section "Facts about Burglaries." This helps us get to know how the criminals work. We urge you to read these safety tips and put them into practice.

Lock up your home and your vehicles

- 1. Never leave your keys in your vehicles
- 2. Never leave your car running, unattended
- 3. Always hide valuables inside of your vehicle, making it appear that there is nothing in your car
- 4. Never leave a wallet or purse in your vehicle
- 4. Never leave a wallet or purse in your vehicle
- Lock your doors and windows to your car and home
 When you leave, go to a neighbors, go out on the lake
- lock everything up.
- 7. Keep your garage door closed
- 8. If it's hard to burglarize you or steal your car/belongings, criminals will not do it.
- 9. Do not make their risk worth their reward

Illumination is important

- 1. Light up your property
- 2. Use motion activated lights
- 3. Close your curtains/drapes at night
- 4. Criminals do not like being seen, make it harder for them to conceal themselves

Facts about Burglaries

- Most burglaries and thefts occur during the day.
- Burglars will often case a neighborhood and look for the "target" that is easiest, or has the highest reward associated with the risk involved. This surveillance can occur over several days.
- Burglars will often come right to your front door and knock or ring the doorbell. This lets them know if you are home. Burglars don't want you to be home.
- If someone strange comes to the door and you answer it, do not give any personal information or even speak to them in any detail about anything.
- If you are familiar with your neighbors and you don't recognize a person hanging out there, then they don't belong there. Don't hesitate to call 911 and ask for an officer to locate these people.
- If someone suspicious is driving a car, do your best to get a description of the vehicle/license plate. It helps us locate the suspect more quickly.
- Be cautious of door-to-door salespeople.
- Be cautious of people telling you a story to play on your emotions.
- Be vigilant of nervous behavior criminals get nervous too, especially when someone is home that they didn't expect.

Facts about Home Security

- Home security systems are important to have. Criminals usually do not target homes with alarm systems, however they also understand the time it takes to notify law enforcement. Make sure cameras cover every angle of your house, driveway, and boat - anything you want to protect. Making the cameras visible will increase safety.
- Do not rely completely on Alarm Systems to protect you. The reality

of law enforcement is that we never have enough Officers on duty to be at your house within 3 minutes every time. When your alarm goes off, the alert is sent to a call center. The call center tries to reach you. If you can't verify the false alarm, or they can't reach you, the call center calls dispatch. Dispatch posts a call, and if the officer is available, the officer will go to your house. This can take over 10 minutes before the officer even gets the call. By that time, the suspect is gone and you have been victimized.

- It is always a good idea to have video cameras. Cameras with a DVR or Cloud Based Storage System are ideal, as you will be able to provide the footage to Law Enforcement should anything happen, which will help in the identification and prosecution of the suspects.
- If you have a DVR storage unit, lock the DVR up in a secure area. Many criminals have broken the DVR, taken the SD Card of the Hard Drive and made them useless because the DVR was left out in the open. Cloud based storage is more secure.

The Elkhart County Police advise us that: Neighbors can protect neighbors.

- 1. Get to know your neighbors
- 2. Neighbors keep an eye out for anything abnormal on your property and theirs.
- 3. If you see something, say something, and call or text 911
- 4. Join social media groups as a neighborhood like the Simonton Lake E-mail Alert System
