





WHAT NOT TO PUT INTO THE SEWER

There are some things you can do to make your grinder pump continue to work.

Remember these letters: F.O.G.S.

F stands for Fats

O stands for Oils

G stands for Grease

S stands for Sanitary “disposable” wipes

Grease and fats clog up pipes which eventually need to be cleaned out. And, those disposable sanitary wipes, well, for our system, they are NOT disposable.

BOTTOM LINE: DO NOT PUT F.O.G.S INTO THE SYSTEM!

CONSERVANCY PURPOSES

The Conservancy deals with the following:

Sewer System, Drainage, Erosion, Sewer, Sediment Removal, Weed Control, Issues that Improve Recreational Use of the Lake (Example: ADA Compliant Pier).

If you are new to the lake, you will want to contact the Conservancy District to make sure your account is in order and that the name of the bill is yours.

NO RUN-OFF WATER IN THE SEWER

Please redirect your downspouts out of the sewer system and into your yard away from your home. Run-off water that goes into the sewer is treated like sewer water. We are charged by the volume we send into the city of Elkhart.

BE CAREFUL WHERE YOU DIG!

The sewer system is pressurized. If you puncture the line, you will have a fountain of sewage. Call 811 before you dig!

BUOYS ANNUAL MAINTENANCE

Purchasing navigational buoys falls under the purposes of the Simonton Lake Conservancy. In early May, volunteers take a boat trip to see which buoys need repair or have been moved out of place.

Then before Memorial Day, a boat trip is taken at night to see which buoys need new solar lights. (All of our navigational buoys outside the Ecozone have lights.)

Then, a team of volunteers replaces lights, moves buoys into their correct position, and replaces damaged buoys.

Thanks to Ryan Matherly, Bob Evans, and Randy Hoff for working on the buoys this summer.



ZONING THE CITY ANNEXES MORE OF OSOLO TOWNSHIP

Osolo Township is one of 16 townships in Elkhart County. The map below shows Osolo Township in RED. The cities in Elkhart County are shown in GRAY. As you can see the city has grown into Osolo Township and continues to eat up parts of the township as it annexes land.



OSOLO TOWNSHIP'S BOUNDARIES ARE:

- To the North-the Michigan/Indiana state line
- To the East-County Road 17 from the state line to the St. Joe River
- To the South-The St. Joe River to Violet Road (near Greenleaf) and then west along California Road
- To the West-From the California Road/Indiana 19 intersection north to the John Weaver Parkway then following a northern route from Willard Road across Boot Lake and to the state line just west of Adamsville Road

HOW CAN THE CITY OF ELKHART ANNEX PART OF OSOLO TOWNSHIP?

Owners of land can request to be annexed. Why? To reap the benefits of the services offered by the city. Other times, the City annexes property which will benefit the City by bringing in tax dollars.

When the city annexes parts of Osolo Township, Osolo Township loses the property taxes generated by that piece of land and the city gains. It is our property taxes that support our fire and emergency services.

In an informative post on the Simonton Lake Vacation Rentals Blog site, the author wrote an article titled, ANNEXATION EFFORTS NEAR SIMONTON LAKE: COMMUNITY CONCERNS AND CITY EXPANSION. Excerpts from that article are noted in italics below.

RECENT ANNEXATION ACTIVITIES BY THE ELKHART CITY COUNCIL

"In 2024, the City of Elkhart proposed annexing land at the northwest corner of County Road 4 and County Road 17, known as "Elkhart East Area A." This area, owned by Almac Inc., is near the industrialized zone and close to the Elkhart Bog-Overholt CEAS nature preserve. The annexation was approved by the City Council on June 17, 2024. This land was formerly part of Osolo Township.

Additionally, in November 2024, the Plan Commission recommended approval of annexing land generally at the intersection of County Road 17 and County Road 6, encompassing parts of Osolo and Washington Townships. This area includes both developed and undeveloped parcels within Elkhart East Phase I."

On July 7, 2025, the City Council approved the annexation of the area including the RV Hall of Fame And the Casey's Service Center at the corner of County Road 6 and County Road 17. In both cases, the owners of the properties petitioned to be annexed. This brings to them city water and sewer. Casey's was formerly on the Osolo Township tax rolls.

IF THE CITY SHOULD TRY TO ANNEX THE SIMONTON LAKE AREA, WHY SHOULD LAKE RESIDENTS BE CONCERNED?

- **Tax Implications:** Annexation could lead to increased property taxes for residents if the lake area is incorporated into the city.
- **Public Services:** Changes in jurisdiction may affect services such as emergency response, road maintenance, and public utilities. (SEWER AND WATER)
- **Environmental Impact:** Development near the lake could impact the health of the lake, including water quality, and impact on the watershed.

Last year, at the June 17, 2024, meeting as the City Council discussed annexation we lake we lake residents were so fortunate the we had both Doug Reese and Fire Chief Smith in the audience speaking on our behalf. Both men emphasized the need for transparency and community involvement in such decisions.

HOW DOES AN AREA GET ANNEXED?

Indiana law stipulates that for an area to be annexed; it must be contiguous to existing city boundaries. The annexation process involves several steps:

1. **Petition Submission:** Property owners or the city submit to the Plan Commission a petition for annexation.
2. **Plan Commission Review:** The Plan Commission evaluates the proposal and makes a recommendation.
3. **City Council Approval:** The City Council votes on the annexation ordinance.
4. **Waiting Period:** If approved, there's a 30-day (for voluntary annexations) or 90-day (for other cases) waiting period before the annexation becomes effective provided. During this time a remonstrance can be filed.

CAN THE CITY ANNEX US IF WE ARE IN A CONSERVANCY DISTRICT?

Yes, according to Indiana Code, a city can take over a sewer conservancy, often as part of an annexation process.

- **Negotiation and agreement:** The city and the conservancy district may negotiate a purchase agreement for the district's assets, like the sewer system.
- **Legal Process:** State law outlines the specific steps required for annexation, such as obtaining signatures from a certain percentage of property owners within the district and holding public hearings.

This process involves legal and administrative steps, and the jurisdiction over activities of a conservancy district ultimately lies with the circuit court that established it.

BOTTOM LINE: Let's be watching this issue as we move forward.

FEEDING DEER : JUST SAY NO

INDIANA DEPARTMENT OF NATURAL RESOURCES - DIVISION OF FISH AND WILDLIFE

WHY DO PEOPLE FEED DEER?

Feeding wild animals can be an enjoyable experience. Many Hoosiers enjoy seeing white-tailed deer up close and feel good about providing an easy meal, especially when food is scarce. Hunters often put out corn or apples so they can learn about deer in their hunting spot. Unfortunately, despite the immediate pleasure for human and deer, feeding wild animals causes more harm than good.

WHY SHOULDN'T I FEED DEER?

1. Habituation: Deer that are fed by humans become dependent on the easy food source and stop foraging. Deer are much better at feeding themselves on their own. When you feed deer and then stop, or when the food temporarily runs out, they will go hungry and may become a nuisance as they search for more easy food. Once deer are habituated, they can become demanding, even bumping at doors and windows to get their expected hand-out. It may seem manageable to feed a doe with two fawns in the spring, but by fall they become three adults demanding dinner every day. Additionally, landscaping and vegetation can be damaged where deer are concentrated around feeding areas. Before you put out food for deer, keep in mind that they are wild animals, not pets, and it's better for you and for them if they stay wild.

2. Disrupting their natural biology: It's easy to feel empathy for deer during a harsh winter, with no apparent food to eat. It may seem they depend on you to survive. Deer, however, are adapted for surviving long, cold winters in Indiana. Their fur provides insulation. Deer stock up on fat in the fall so they do not need to eat much in the winter. Additionally, their metabolism slows and they restrict movement to conserve calories. By spring, the deer have slimmed down but are healthy. Feeding deer, especially with high-calorie food, interrupts this natural pattern and speeds up their metabolism, making them burn fat reserves faster. Unlike humans, deer have a specific blend of microbes in their stomach that break down their naturally high-fiber diet. These microbes take several weeks to adjust to new foods. During this period, deer are susceptible to corn-induced acidosis, which can cause diarrhea, dehydration and death. This creates a situation where you must continue feeding them through the winter, though they would have otherwise survived on their own before you intervened.

3. Spreading disease: Under normal circumstances, deer spread out when they forage. When deer are given supplemental food, however, they congregate closer than they would in the wild. Close proximity is a way for deer to spread disease. Though it has not yet been found in Indiana, chronic wasting disease (CWD) is spreading in the midwest, and is a serious threat to deer. CWD spreads easily through saliva, urine, feces, and other methods and stays active and infectious in the soil for years. By not giving deer an incentive to congregate, you help slow disease transmission.

4. Deer feed is unhealthy "junk food": Several medical complications in deer arise from diets based on corn and pellets as opposed to natural woody browse. Acidosis, enterotoxemia, and aflatoxin all will cause 2-3 weeks of extreme discomfort for deer as the bacteria in their digestive system adjust to accommodate the new chemistry of the foreign food. Not all deer survive this transition, especially if they are already stressed from harsh weather or sickness. Even worse, deer go through the process again when they stop getting fed, making deer feed twice as harmful.



The Wildlife Management Institute offers an insightful evaluation of feeding wildlife as follows:

Supplemental feeding — however well intentioned — either compromises the animal's wildness or wellness, or it interferes with the essential natural processes of selection. For deer will crowd around a reliable food source, becoming dependent on the unnatural food and potentially spreading disease. the long-term benefit of big game wildlife populations, supplemental feeding is an accident waiting to happen. When and where such feeding is done, it is undertaken only — if not expressly — for the interest of people, because the fed animals almost invariably will not benefit and very likely will be harmed by the practice (Feeding Wildlife: Just Say No).

WHAT CAN I DO?

If you are already feeding deer and would like to stop, slowly decrease the amount of food you are offering. Do not remove all the food at once. This way, the deer will have time to adjust their browsing habits and learn to eat on their own again.

- Read the Indiana DNR Boating Manual. Available online. See the link at the Simonton Lake HOA website, www.simontonlakehoa.com
- Are you hooked up to the Simonton Lake Sewer? If you are, you'll have a grinder pump in your yard. Make sure your name is now on the account. Call the Conservancy Office at 574-206-8485.
- Water quality is something we all must protect. Don't blow yard waste or leaves into the lake. Be careful about using fertilizer near the water.
- Putting in a pier? Make sure you know the rules for piers. Check this out at the Indiana DNR website, in.gov/dnr/water
- Don't feed the geese or ducks. When ducks and geese get food from us, additional waterfowl who visit our lake will stay because it appears that there is plenty of food.
- Join the Simonton Lake Area Homeowners' Association. You'll find a membership form in your gift bag and in the "Simonton Says" magazine.
- Read the quarterly "Simonton Says" magazine to keep up with what is happening at the lake



SIMONTON LAKE SEWER PUNCTURED - LAKE AT RISK

Two years ago, Surf Internet was given a permit by Elkhart County to run fiber optic cable along the roadways of Elkhart County. The company was very cooperative with lake residents and the HOA even hosted a meeting at which the SURF leaders explained their process and their system. However, the underground boring workers did puncture the sewer system.

Now, it appears Frontier is laying its own cable along lake roads AND causing trouble with our Simonton Lake Conservancy sewer system. The system has been punctured several times over the past several months.

The latest puncture was so severe that a small amount of wastewater entered the lake. Sandbags were deployed and the Elkhart County Health Department was called in to assess the situation. It is the Health Department which does yearly testing of Elkhart County lakes, rivers, creeks, and ditches to determine the contaminants in the water. If a lake is closed because of health reasons, they are the ones to make the decision.

As you know your yard as it meets the county road includes a RIGHT OF WAY. As defined in "ELKHART COUNTY STREET STANDARDS" this is "a strip of land occupied by or dedicated to Elkhart County to be used as by a street, pedestrian-way, crosswalk, railroad, electric transmission line, oil or gas pipeline, water main, sanitary or storm sewer main, special landscaping, or any other public use. This is where the telephone poles, electrical boxes, sewer line and underground cables can and are placed.

WHY DID THE BORING COMPANIES PUNCTURE OUR SEWER?

Our sewer lines, when buried in 1999-2000 included "tracer wires" which can be detected above ground. Before you dig you are often reminded to call 811. This phone call then alerts you, or whoever is digging, where the

underground utilities are located. Of course, there are errors but if this detection is done carefully and correctly, instance of damage to the sewer system should be very rare.

In addition, residents have been dissatisfied with the mess left in their lawns. While these companies are in the public right of way, most of the time that right-of-way appears to be part of my lawn. I can only speak to how SURF treated us in that they cleaned up and left minimal yard damage to fix. FRONTIER has not yet been down North Shore Drive at the time this article was written. We'll see how they do. But it seems like any utility company who is competing for my business would want to keep me happy with their work.

On June 19, I sent the following Lake Alert

On Thursday, June 19 a damaged sewer line was repaired on Twilight Drive. Measures were taken to repair the line and prevent sewage from entering the lake. The Elkhart County Board of Health was on site, and they were satisfied with the measures taken.

NEVER, AT ANY TIME, DID ANY SEWAGE COME CLOSE TO THE LAKE. If that had been the case, the Elkhart County Health Department would have closed the lake until remediation had been done.

Please do not believe rumors. If you have a question or a concern, contact a member of the Conservancy Board for the truth. Go to the Simonton Lake Conservancy District website for board member's names and contact information. Or contact the Elkhart County Health Department.

That middle-bold paragraph is incorrect. There was a minimal amount of wastewater that entered the lake. The County Health Department DID declare the lake and people using the lake were not in danger. My apologies.

LAKE ROADS IN NEED OF REPAIR

The HOA has received several concerns from residents about the condition of our roads. Lake Drive seems to have had a “patch job” done that neighbors said was not done well.

In a check of the list of road projects for 2025 at the Elkhart County Highway Department we find none of our streets listed.

In addition, this information was reported by WNDU in early June:

“Elkhart County may already be seeing the effects of decreased funding at the state level for road projects.

According to our reporting partners at **The Goshen News**, three appropriation requests were approved for 2025 highway department routine maintenance projects.

Elkhart County Commissioner, Suzie Weirick says due to a combination of Senate Bill 1 and new moves in Indianapolis, the county should expect a shortfall from the state.

Additionally, you should continue to see increases in what the county is covering.”

We encourage you to report potholes and other road issues directly to the Elkhart County Highway Department.

FALL LEAF COLLECTION

The next issue of Simonton Says comes out in November, so we must cover this issue now.

Because of the poor results from relying on the county leaf collection contestants, the HOA has no organized free way to get rid of your leaves.

You may contact the county and arrange to have a contestant pick up your leaves. But this will be on your own and not organized by the HOA.

IF I DON'T BURN MY LEAVES, WHAT CAN I DO WITH THEM?

- The Elkhart County Landfill at 59530 C. R. 7 (Oakland Avenue in the city) will take leaves for free on any day that they are open. The Landfill is just south of the U.S. 20 Bypass.
If you have room on your property leaves, make great compost for use on gardens, come springtime.
- Check with your trash removal service to see if they will pick up your leaves.

• DON'T PUT LEAVES INTO THE LAKE!

ELKHART COUNTY BURNING REGULATIONS

Being allowed to burn does not mean you can burn anything you want, anytime. If you assume this, you may be ticketed.

Here are the Elkhart County Burning Regulations:

- Private residential open burning is allowed where the building contains four or fewer dwelling units. Apartments, condominium complexes, mobile home parks, and businesses may not burn.
- A person may burn vegetation from a farm, orchard, nursery, or drainage ditch.
- Recreational or ceremonial fires are allowed but cannot be used for disposal purposes.
- It is always against the law to burn trash such as household waste, plastic, batteries, rubber, diapers, and painted or stained wood.

If you choose to burn, these conditions must always be followed:

- Fires must be attended at all times during burning until completely extinguished.
- A fire must be extinguished at any time if it creates a:
 - Pollution problem
 - Threat to public health
 - Nuisance
 - Fire hazard
- Burning may not be conducted during unfavorable meteorological conditions, such as high winds, temperature inversions, air stagnation, or when a pollution alert or air quality action day has been declared.
- Private residential open burning must be during daylight hours. All fires must be extinguished before sunset. (Recreational or ceremonial fires are allowed after sunset but cannot be used for disposal purposes.)
- Private residential open burning must be in a non-combustible container that is sufficiently vented and induce adequate primary combustion and has enclosed sides and a bottom. A burn barrel is not well vented.
- Only clean wood products and paper may be burned. "Clean wood products" means wood products, including vegetation, which are not coated with stain, paint, glue, or other coating material.

SAFETY ON THE LAKE

On several nights in July boaters have noticed a swimmer with no float buoy after dark.

In fact boats have almost run over this swimmer. **THIS IS A DANGEROUS SITUATION!**

Swimmers going beyond 200 feet from shore must have a float buoy!! Swimming at night with no float buoy more than 200 feet from shore is **EXTREMELY DANGEROUS**.

In a swimmer vs. boat motor scenario the motor always wins

How about just following the law. Here are a few violations that have been reported to Simonton Says in the Summer of 2025:

- Follow the instructions on the DNR Approved buoys.
 - **Idle speed in the channels.** “Idle Speed means the lowest possible speed, not to exceed 5 miles per hour so as to maintain steerage and maintain minimal wake.”
 - **Stay out of the Ecozone.** No motorized boats are allowed in the Ecozone.
- **Speeding boats going too close to swim areas along the shoreline.**
- **Boats going outside instead of between the buoys on each end of the main channel.**
- **Swimmers beyond 200 feet from shore with no**

float buoy. Do not swim beyond 200 feet from shore without a swim float.

- **Swimmers at night with no float buoy beyond 200 feet from shore.**
- **No lifejackets on drivers of wave runners.** Each person on a wave runner must wear a lifejacket.
- **No observer.** When pulling a tuber or skier, an observer is required.
- **Buoys:** Do not tamper with, moor to, move, or damage a navigational buoy. Doing so is a federal offense. The buoys placed on this lake are paid for with our tax dollars.
- **Skiing and tubing are prohibited between sunset and sunrise.** When the sun starts sinking and we enter twilight or dusk, can you really see who you are pulling on a tube or skis?
